

CFA-VAG MicroGallery Exhibit

Application, Procedures & Agreement Part 1 of 3

I am applying to show my work at one of the Center for the Arts (CFA) Microgalleries. If accepted, I am responsible for the delivery, installation, maintenance and removal of my solo or group exhibit according to my exhibit period. Neither the Microgallery nor the CFA can store my artwork that I have not removed, and it may be disposed in accordance with NH law if necessary.

My artwork will be for sale when this exhibit opens. I understand that the CFA produces advertising and promotional material for my exhibit. By applying for this exhibit, I give the CFA the right to photograph my work and any information I send for the purposes of promotion of this exhibit and my art.

The CFA and Microgalleries provide an exhibit space, beverages and snacks for my opening reception. In return, I will attend the First Friday opening reception, and intend to replace my artwork that is sold at this exhibit with my own comparable work. I will maintain the exhibit for the duration of the exhibit period.

Neither the CFA nor any other entity involved with this exhibit provides insurance for my artwork, and is not responsible for any loss or damage. I may provide my own insurance.

I will receive 70% of the price of my artwork that is sold at this exhibit. The CFA will retain 30%. There is a \$25 application fee payable upon acceptance to cover administrative costs.

Only CFA Visual Arts Guild (VAG) members may exhibit at the CFA Microgalleries in New London, NH. To join, go to https://centerfortheartsnh.org/artist The venues are Bar Harbor Bank & Trust (321 Main St.), New London Inn (353 Main St.), Blue Loon Bakery (across from Morgan Hill Bookstore at Lovering Lane), the NL Barn playhouse, and the New London Hospital, Grounds Cafe, and Whipple Hall. Exhibit duration is three months and runs February - April, May-July, August -October, and November- January.

Each artist, whether solo or in a group, must complete a separate copy of this Proposal & Agreement.

Framed, gallery-wrapped and rigid-substrate-mounted artwork is acceptable. My frame will be professional quality construction and finish. **I may request variation from requirements in this paragraph.**
